## **AWARD**

Upon providing all parties with an opportunity to be heard, having examined his jurisdiction and considered the factual and legal arguments as well as the requests for relief submitted in this case, the Arbitrator decides as follows:

- 1. Nadi Naft Al-Janoob (South Oil Sports Club) is ordered to pay Mr. Pascal Beyrouthy a total of USD 31,600.00 net, by way of unpaid agency fees (such total sum comprising individual agency fees of USD 3,600.00 net of all Lebanese charges as well as all other applicable taxes, plus USD 10,500, net, plus USD 8,400.00 net, plus USD 9,100, net) together with interest at 5% per annum from 25 February 2018 until payment in full.
- 2. The costs of this arbitration until the present Award, which were determined by the President of the BAT to be in the amount of EUR 3,850.00 shall be borne by Nadi Naft Al-Janoob (South Oil Sports Club) alone. Accordingly, Nadi Naft Al-Janoob (South Oil Sports Club) shall pay EUR 3,850.00 to Mr. Pascal Beyrouthy. The balance of the Advance on Costs, in the amount of EUR 1638.11, will be reimbursed to Mr. Pascal Beyrouthy by the BAT.
- 3. Nadi Naft Al-Janoob (South Oil Sports Club) is ordered to pay Mr. Pascal Beyrouthy EUR 5,150.00 as a contribution to his legal fees and expenses.
- 4. Any arbitration costs associated with a Request for Reasons (see attached Notice) shall be advanced and borne by the requesting party
- 5. Any other or further-reaching requests for relief are dismissed.

## Notice about Request for Reasons

in accordance with Articles 16.2 of the BAT Rules:

"By agreeing to submit their dispute to arbitration under these Rules, the Parties agree that, where the value of the dispute does not exceed EUR 100,000, the Arbitrator shall issue an award without reasons, provided, however, that the Arbitrator shall deliver reasons if a party

- a) files a request to that effect at any stage from when the Request for Arbitration is filed until no later than ten (10) days after the notification of the award without reasons; and
- b) pays the respective advance on costs as determined and within the time limit set by the BAT Secretariat."

The Parties are herewith informed that the amount to be paid as an advance on costs for a reasoned award in this case has been set by the BAT Secretariat to **EUR 5,000.00**. The time limit for payment thereof will be set by the BAT Secretariat upon receipt of the Request for Reasons, if any.
