For the sake of consistency, 'team A' is always the (initial) offensive team, while 'team B' is the defensive team. A1 - A5, B1 - B5 are players on the court; A6 - A12, B6 - B12 are substitutes.

Please circle the correct answer – only one mark per answer

1	During the time-out, the players may leave the playing court and sit on the team bench.	YES	NO	
2	A1 releases the ball on the jump shot, returns to the floor with one foot and is then fouled by B1. B1 foul is committed during A1 act of shooting.	YES	NO	
3	There shall be 2 separate, distinctly different and loud signals, one for the shot clock operator and one for the scorer/timer.	YES	NO	
4	A3 is awarded 2 free throws. The ball on the first free throw rebounds from the ring and still has a chance to enter the basket. B5 taps the ball away. The referee calls technical foul on B5.	YES	NO	
5	The playing court is 26 m x 14 m measured from the inside edge of the boundary line.	YES	NO	
6	A2 is setting an illegal screen, what is called, at the time when the A3 has already started the act of shooting but the ball has not yet left A3's hands. The ball enters the basket. The goal shall count.	YES	NO	
7	The centre line is part of the backcourt.	YES	NO	
8	A2 pass to A4 in the frontcourt is deflected by B1. The ball then touches the ring of team B basket. The shot clock shall be reset.	YES	NO	
9	During his dribble, A1 loses his balance and steps out-of-bounds without touching the ball. A1 returns on the court and continues his dribble. This is a legal play.	YES	NO	
10	A1 straddling the centre line receives the ball from A2 who is in the backcourt. The ball has gone to the frontcourt.		NO	
11	The coach shall designate the free-throw shooter of his team in case of a technical foul.	YES	NO	
12	The score is tied at the end of the game. The game has ended.		NO	
13	During a throw-in, regardless whether the game clock is stopped or not, or during a free throw, in the judgement of the referee, a player deliberately delays the process of taking the ball. The referee calls a technical foul.	YES	NO	



14	The game consists of 4 periods of 10 minutes.	YES	NO
15	None of the team B players occupy the first rebound spaces during A1 last free throw. A1 misses the free throw. A replacement free throw be awarded to A1.	YES	NO
16	The shot clock signal sounds while team A is in control of the ball. The ball becomes dead immediately.	YES	NO
17	With 1:23 remaining on the game clock in the 4th period, A1 commits a travelling violation in his frontcourt. Team A is granted a time-out. The game shall be resumed with team B frontcourt throw-in at the throw-in line.	YES	NO
18	A1 passes the ball to A2. The ball is deflected by B1 who is running after the ball to catch it. Neither team controls the ball at this time.	YES	NO
19	A3 scores a field goal. Team B is granted a time-out. Following the time-out, B4 thrower-in runs along the endline before releasing the ball. This is a violation.	YES	NO
20	During an initial jump ball, A1 jumper taps the ball out-of-bounds. B1 has the ball for the throw-in when A2 commits an unsportsmanlike foul on B2. With B2 having the ball at his disposal for his 1st free throw, team B has gained the control of the live ball on the court. Team A shall be entitled to the next alternating possession.	YES	NO
21	A1 shot for a 3-point field goal is on the upward flight when the ball is touched by B1. Later B2 touches the backboard when the ball is in contact with the ring, causing the backboard to vibrate and therefore the ball did not enter the basket. This is B2 defensive interference and A1 is awarded 3 points.	YES	NO
22	A1 throw-in lodges between the ring and the backboard. This is a jump ball situation.	YES	NO
23	A1 is in the restricted area for 2.5 seconds and he receives a pass. A1 starts a dribble and releases the ball for a shot for goal after 4 seconds have passed. This is a 3-second violation.	YES	NO
24	After the unsuccessful last or only free throw, the game clock shall start when the ball touches the ring.	YES	NO
25	A1 in his backcourt is dribbling for 4 seconds when a fight starts. A7 and B9 are disqualified for entering the playing court. Team A shall resume the game with a throw-in at the centre line extended. A2 passes the ball to A3 in his backcourt. Team A shall have 4 seconds to move the ball into its frontcourt.	YES	NO
