**NOTE:**

For the sake of consistency, 'team A' is always the (initial) offensive team, while 'team B' is the defensive team. A1 – A5, B1 – B5 are players on the court; A6 – A12, B6 – B12 are substitutes.

**Please circle the correct answer – only one mark per answer**

STATEMENT		ANSWER	
1	The centre line is neither part of the backcourt nor the frontcourt.	YES	NO
2	A1 throw-in to A2 is in the air. Team A has control of the ball at this time.	YES	NO
3	A1 is in the restricted area for 2 seconds. A1 steps out of the restricted area with his left foot and lifts his right foot. A1 returns to the restricted area and remains there for additional 2 seconds. This is a 3-seconds violation.	YES	NO
4	Both teams have started to play the 2nd half in the wrong direction. A1 accidentally scores a 2-point field goal in his own basket. Team B captain who is sitting on the team bench shall be awarded 2 points.	YES	NO
5	All periods shall start with a jump ball.	YES	NO
6	A1 catches the ball with one foot on the floor. A1 shall be entitled to use only this foot as pivot foot.	YES	NO
7	A1 thrower-in at a designated throw-in spot, places the ball on the floor. A2 who is on the playing court goes out-of-bounds, takes the ball and executes the throw-in. This is legal.	YES	NO
8	The shirts must be of the same dominant colour front and back.	YES	NO
9	The ball on the A4 shot for a field goal touches the backboard and it is completely above the level of the ring when B4 touches the ball. This is the goaltending violation.	YES	NO
10	A1 has not yet dribbled. A1 throws the ball against the backboard and catches it again before another player has touched the ball. A1 shall be entitled now to start a dribble.	YES	NO
11	After the last free throw, the ball rebounds from the ring. The ball is touched by B1 and the ball to enter the basket. The goal shall count 2 points.	YES	NO
12	A2 last free throw neither touches the ring nor enters the basket. The game shall be resumed with a team B throw-in at the free-throw line extended.	YES	NO

13	After a dribble, A1 throws the ball deliberately against the backboard and catches it again before it has touched another player. This is legal.	YES	NO
14	With 10 seconds remaining on the game clock in the 4th period and with 5 seconds on the shot clock for team A, B1 deliberately kicks the ball in his backcourt causing the ball to go out-of-bounds. The game shall be resumed with team A frontcourt throw-in with 10 seconds on the game clock and with shot clock turned off.	YES	NO
15	A1 is dribbling in his backcourt and ends his dribble holding the ball and straddling the centre line. A1 passes the ball to A2 who is also straddling the centre line. The 8 second period shall continue.	YES	NO
16	Both teams have started to play the 2nd half in the wrong direction. A1 accidentally scores a 2-point field goal in his own basket. The goal shall count.	YES	NO
17	During A3's unsuccessful last or only free-throw, both A4 and B4 in their free-throw rebound places commit a violation. This is a jump ball situation.	YES	NO
18	A1 passes the ball from his backcourt to A2 who is straddling the centre line. Referee shall end the 8-second count.	YES	NO
19	The time-out period ends and the referee beckons the teams on the playing court. Coach A continues to instruct his team in the team bench area. The coach has already been warned for the same behaviour, therefore the referee wants to charge him an additional time-out. The scorer notifies the referee that team A has no time-out left. Coach A shall be charged with the technical foul.	YES	NO
20	A1 shot for a field goal is in the air when the shot clock signal sounds. The ball enters the basket. Coach A request for a time-out is not granted.	YES	NO
21	The home team (team A mentioned in the scoresheet) coach A shall be the first to confirm his list of players and 5 players to start the game.	YES	NO
22	On a fast break, A1 ends his dribble and throws the ball against the backboard. A1 jumps, catches the ball again before it is touched by another player and scores a goal by dunking. This is a legal play.	YES	NO
23	A1 is holding the ball. A1 loses his balance and falls on the floor. This is legal.	YES	NO
24	Team A has fewer than 5 players on the playing court ready to start the 3rd period due to the injuries, disqualifications etc. Team A shall continue the game with less than 5 players.	YES	NO
25	A4 unsuccessful attempt to dunk the ball rebounds from the ring, after which the shot clock signal sounds in error. This is a jump ball situation.	YES	NO
