For the sake of consistency, 'team A' is always the (initial) offensive team, while 'team B' is the defensive team. A1 - A5, B1 - B5 are players on the court; A6 - A12, B6 - B12 are substitutes.

STATEMENT			ANSWER	
1	When the shot clock is stopped and the signal sounds, the game clock continues to run and may be stopped, if necessary, manually.	YES	NO	
2	During a situation on the court which may lead to the fight, A6 and A9 leave the team bench area. Coach A shall be charged with 2 technical fouls, recorded as 'B'.	YES	NO	
3	During A1 shot for a field goal, the ball bounces on the ring when A2 pushes illegally B2 on the rebound and the foul is called. The ball enters the basket. The goal shall count.	YES	NO	
4	Coach A requests the scorer that A6 substitutes for A1. This is the correct substitution procedure.	YES	NO	
5	A1 thrower-in passes the ball to A2. A2 receives the ball with one foot touching the boundary line. The game shall be resumed with team B throw-in at the place where A2 touched the line.	YES	NO	
6	A1 shot for a field goal rebounds from the ring over the backboard without touching the basket supports. The game shall continue.	YES	NO	
7	A3 appears to be injured and the game is stopped. A time-out is requested by team B. At the end of the time-out, A3 has recovered and asks to remain in the game and continue to play. The A3's request shall be accepted.	YES	NO	
8	The thrower-in with the ball in his hands steps on (but not over) the boundary line. This is a violation.	YES	NO	
9	A4 is holding the ball on the playing court near the sideline. B4 who is closely guarding A4 has one foot out-of-bounds. In pivoting, A4 body touches B4 body. This is A4 violation.		NO	
10	During a time-out, A8 reports to the scorer as a substitute. A8 becomes a player when the time-out has ended.		NO	
11	A4 is awarded 1 free throw. After the referee has stepped into the restricted area to administer the free throw but before the ball is placed at the B4 disposal, team B request a time-out. The time-out shall be granted.	YES	NO	



12	The ball is touched simultaneously by A1 and B1 and has gone out-of-bounds. The possession arrows favours team A. During the throw-in, A2 commits the 5-second violation and the ball is awarded to team B. Team B shall be entitled to a throw-in at the next jump ball situation.	YES	NO
13	A3 is dribbling in his frontcourt near the centre line when A5 commits a 3 second violation. Team B shall be awarded a throw-in at the endline, but not directly behind the backboard.	YES	NO
14	With 1:37 remaining on the game clock in the 4th period, A1 has dribbled the ball in his frontcourt when B1 taps the ball to team A backcourt where A2 starts to dribble the ball. B2 now taps the ball out-of- bounds in the team A backcourt with 17 seconds remaining on the shot clock. Team A is granted a time-out. The game shall be resumed with team A throw-in at the throw-in line in its frontcourt with 14 seconds on the shot clock.	YES	NO
15	Team A has the control of the ball in its backcourt for 4 seconds when a fighting situation between A1 and B1 occurs and some members of both teams leave their bench areas. Both players and some members of both teams are disqualified for leaving their team bench areas. All penalties are cancelled. The game shall be resumed with team A throw-in at the centre line extended and with 20 seconds remaining on the shot clock.	YES	NO
16	A4 thrower-in hands the ball to A5 who is on the playing court. This is legal.	YES	NO
17	Team A is granted time-out. While the players are moving to their respective bench areas, A1 pushes B1. This is a technical foul.	YES	NO
18	A2 shot for a goal is on its upward flight when the game clock signal sounds for the end of the game. While the ball is still in its upward flight, it is touched by B2. While the ball is in its downward flight, it is touched by B3. The B3's touch of the ball is the goaltending violation.	YES	NO
19	The game clock and the shot clock shall be operated by 1 person.	YES	NO
20	A1 and B1 have both hands firmly on the ball. While attempting to pull the ball from B1 hands, A1 touches a sideline. The alternating possession arrow favours team A. Team B shall be awarded a throw-in because of an A4 out-of-bounds violation.		NO
21	During a jump ball, the ball becomes live when the ball is tossed by the referee.	YES	NO
22	A1 releases the ball on a shot from the 2-point field goal area. The ball on its upward flight is legally touched by B1 who is in the team A 3-point field goal area. The ball enters the basket. Team A shall be awarded 2 points.		NO
23	With 1:23 to play in the 4th period, the ball is in the hands of a referee to place the ball at the disposal of A3 for a throw-in. B5 causes contact with A2. The referee calls an unsportsmanlike foul on B5.	YES	NO
24	The thrower-in can run along the endline whenever the throw-in is administered from the endline.		NO
25	Team A is awarded a throw-in instead of 2 free throws to A4. During team A throw-in, B1 catches a pass, dribbles and scores a field goal. The error is recognised at this time. The error shall be corrected.	YES	NO
