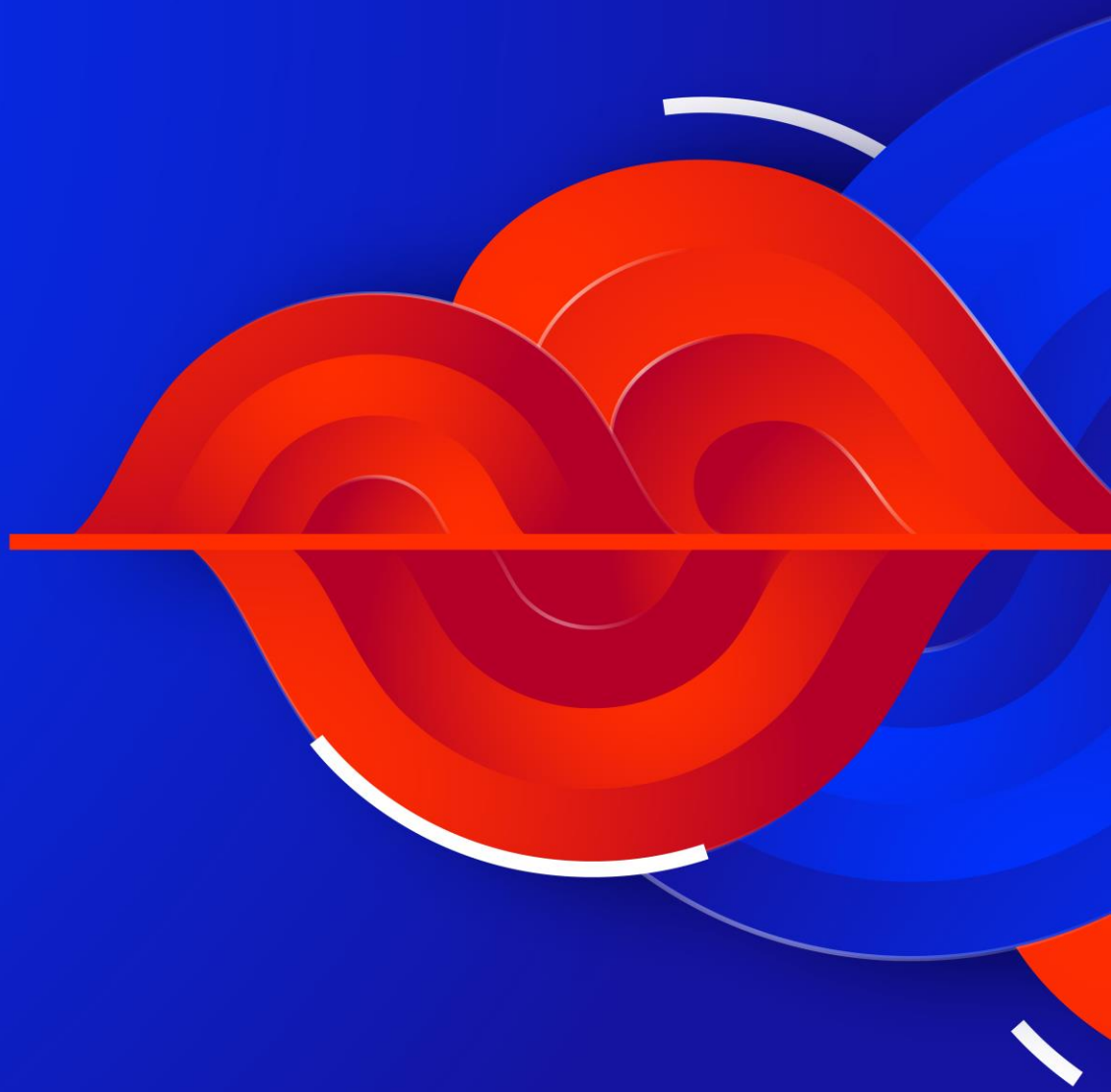

Nationals from 9 following countries require an approval from Immigration Office in Indonesia, based on the Indonesian Calling Visa policy, before travelling for Business, Tourist and Social Visit purposes

# CALLING VISA REQUIRED DOCUMENTS



- Scan copy of the passport cover page and first page with personal details (passport must be valid for at least 6 months)
- Return flight ticket (can be a tentative ticket return)
- Certificate of vaccination (list of approved vaccine to be shared by LOC)
- 1 recent passport-sized color photograph with white background
- Proof Travel insurance
- Employment letter
- Applicant's CV

# 4 SINGLE ENTRY VISA

For all countries not found under Visa exemption, Visa on arrival or Calling Visa, a **Single Entry visa application must be submitted**

- Return flight ticket (can be a tentative ticket return)
- Certificate of vaccination ((all vaccines approved by the World Health Organization)
- 1 recent passport-sized colour photograph with white background
- Proof Travel insurance

# COVID-19 TESTING REQUIREMENTS



All travellers must be fully vaccinated (at least 2 doses) and in possession of proof of vaccine status to enter Indonesia unless you cannot be vaccinated due to health reasons (a certificate from medical professional must be presented to confirm this)

1. PCR test is no longer required to enter Indonesia if traveler fully vaccinated. **Note:** Airlines / carriers may have different requirement to board their transport vehicle regarding PCR test;
2. Showing insurance coverage statement for Covid-19 treatment in Indonesia is no longer required;
3. Download an Indonesian mobile application **PeduliLindungi** (available on Google Play; App Store, App Gallery);
4. Register your Covid-19 vaccine certificate at **PeduliLindungi** app (see attachment) for your access to indoor public places in Indonesia;
5. Show printed or digital proof that you have been fully vaccinated against Covid-19 at least 14 days prior to your departure (exemptions apply to visitors under 18 years old, diplomatic/official government visit, and medically certified persons). **Indonesian citizen who are not fully vaccinated will receive vaccination after quarantine;**
6. A traveler that has been Covid-19 infected is exempted from showing Covid-19 vaccine certificate as long as traveler can show a medical attestation from doctor/hospital/ministry of health or a Covid-19 recovery certificate from departure country (in English) confirming that the traveler is no longer transmitting Covid-19 and not yet possible or cannot receive full dose of Covid-19 vaccine ;
