NOTE:

For the sake of consistency, 'team A' is always the (initial) offensive team, while 'team B' is the defensive team. A1 – A5, B1 – B5 are players on the court; A6 – A12, B6 – B12 are substitutes.

Please circle the correct answer – only one mark per answer

STATEMENT		ANSWER	
1	After 50 seconds of a time-out have elapsed, the timer sounds his signal. Timer sounds his signal 10 seconds later to indicate the end of the time-out. B6 requests the substitution for B1. The request shall be granted.	YES	NO
2	After a dribble, A2 deliberately passes the ball against B1's back. A2 catches the ball again and scores a field goal. This is a violation.	YES	NO
3	A1 receives a pass in the air. A1 returns to the floor with his left foot and then jumps off this foot and lands on both feet simultaneously. A1 then pivots around his left foot. This is legal.	YES	NO
4	Following 2 free-throws as the result of the B1 unsportsmanlike foul, A1 passes the ball out-of-bounds at the endline in team A frontcourt, without touching anyone on the court. Team B shall be awarded a throw-in at the place of the original throw-in and team B shall be entitled to throw-in the ball to both frontcourt and backcourt.	YES	NO
5	An illegal movement of the pivot foot is a travelling violation.	YES	NO
6	A4 is dribbling from his backcourt. A4 stops his dribbling with both feet in the backcourt but the ball being dribbled in the frontcourt. This is legal.	YES	NO
7	A2 is awarded 1 free throw after which B2 is awarded 2 free throws. A2 free throw is not successful. Before the ball becomes live for B2 1st free throw, A6 requests to substitute A2. The request is granted.	YES	NO
8	The ball goes out-of-bounds. Both teams may substitute.	YES	NO
9	A4 is awarded 1 free throw. After the referee has stepped into the restricted area to administer the free throw but before the ball is placed at the B4 disposal, team B request a time-out. The time-out is granted.	YES	NO
10	A4 illegally returns the ball to his backcourt. Team B shall be awarded a throw-in in its frontcourt.	YES	NO
11	The ball on the A4 jump shot for a 2-point field goal is in the air when the shot clock signal sounds. After the signal, B4 commits an unsportsmanlike foul on A4 who is still in the air. The ball then misses the ring. The referee shall award A4 2 free throws, followed by a team A	YES	NO

	throw-in at the centre line extended, opposite the scorer's table.		
12	Team A has been in control of the ball for 15 seconds. A1 passes the ball to A2 and the ball moves across the boundary line. B1 is trying to save the ball from going out of bounds and jumps from the playing court over the boundary line. B1 still in the air taps the ball by one hand of B1 and the ball returns to the playing court where it is caught by A2. Team B has gained control of the ball and the shot clock shall be reset.	YES	NO
13	B1 commits an interference violation. A1 is awarded 2 points. Coach B requests a time-out. The request shall be granted.	YES	NO
14	A1 jumps for a shot for a field goal. B1 blocks the shot while the ball is still in A1 hands. A1 returns to the floor having the ball in his hands. This is a travelling violation.	YES	NO
15	The dimension of the playing court is 26 m x 14 m.	YES	NO
16	Team A has fewer than 5 players on the playing court ready to start the 3rd period due to the injuries, disqualifications etc. Team A shall continue the game with less than 5 players.	YES	NO
17	If it is necessary to protect an injured player, the officials may stop the game immediately.	YES	NO
18	A1 thrower-in pass goes out-of-bounds without touching any player on the playing court. The game shall be resumed with a team B throw-in at the place of the original throw-in.	YES	NO
19	A1 is setting a screen on B1. A1 must face B1 for the screen to be legal.	YES	NO
20	During an A1 alternating possession throw-in, the ball lodges between the ring and the backboard. The game shall be resumed with team B throw-in at the place of the original throw-in.	YES	NO
21	Team A gains control of the live ball on the court from the jump ball. The alternating possession arrow shall be directed towards the team A basket indicating that team B will be entitled to the next alternating possession throw-in.	YES	NO
22	During an endline throw-in, B4 throws the ball over the backboard. This is a violation.	YES	NO
23	The time-out ends and the referee then beckons teams on the playing court. Coach A continues to instruct his team in the team bench area. The referee re-beckons team A on the playing court and team A finally enters the playing court. The referee warns coach A that if the same behaviour is repeated for the second time an additional time-out shall be charged against team A.	YES	NO
24	The 3-second rule applies only when a team is in control of the live ball on any place on the court.	YES	NO
25	A foul is called. The time-out may be granted to either team.	YES	NO
